- To raise \$40,000 for Imagination Library and the General Fund by May 31, 2011 through fund raisers and the Fund Development Committee.

GOAL IV: TO DEVELOP STRONG COMMUNITY IMPACT

OBJECTIVES:

• To sign up 750 children by May 31, 2011.
