#### GOAL III: TO DEVELOP GOOD FISCAL MANAGEMENT

#### **OBJECTIVES:**

- To plan financial management training for Councils and committees by the October 2010 Board meeting. (Training dates to be determined). This will be determined successful if 70% of this group are trained and evaluate the training as a positive experience by May 31, 2011.
- To develop a plan for monitoring and reporting financial information to the League by the October 2010 Board meeting.
- To raise \$40,000 for Imagination Library and the General Fund by May 31, 2011 through fund raisers and the Fund Development Committee.
