a. Done in a Day

- i. Done in a Day sign ups for November, December, and January are available on the website and sign up sheets are also available at the meeting.
- b. Imagination Library
  - i. IL Facts
    - 1. Project was voted in March 2008 to be a five year project with an end date of May 31, 2013
    - 2. First shipment of books were delivered September 2009
    - 3. Currently there are over 1100 children enrolled
    - 4. We have delivered nearly 30,000 books
    - 5. When the project started the goal was to find a financial backer to pay for the program and JLA would be the administrative side, signing up children, maintaining the database but the economy went downward
    - 6. Current and past Imagination Library chairs have approached outside organizations for financial backing, though small amounts have been received, no one has signed on to support us fully or even partially
    - 7. We have spent over \$45,000 of our own money
    - 8. Other Leagues are having the same problem finding financial backing. In today's economy books are not a top priority with unemployment over 8% nationally.
  - ii. The board has come up with two options for how to proceed with Imagination Library:
    - 1. Option 1
      - a. Continue to pay for everyone currently enrolled regardless of where they live. This will cost \$90,000 over the next five years.
      - b. How do we afford this?
        - i. Make request to the Community Foundation to withdrawal all funds = \$100,000. IF they agree to the full amount we have our solution. IF they agree to a lesser amount, JLA will have to make up the rest through fundraising and a withdrawal from our Vanguard account.
        - ii. If the Community Foundation declines our request we will need to pull 100% of the funds from our Vanguard account and continue to fundraise.
      - c. Bombard the Capital Region w/press showing JLA's commitment to IL and our financial commitment.
    - 2. Option 2
      - a. Terminate the program as of May 31, 2013. This will cost us an additional \$19,552 for those currently enrolled and approximately \$700 for postcards/postage to make parents aware.
      - b. How do we afford this?
        - i. Use funds from our Vanguard account
        - ii. Request a withdrawal from the Community Foundation

- iii. Solely fund raise
- c. Bombard the Capital Region w/press, over the five years we gave out over 30,000 books, touched over 1100 children, spent over \$45,000...
- d. We will now focus our efforts and funds on the more pressing needs of the community brought on by this recession.

- iv. Vote
  - 1. There will be a vote on IL at the March GMM.
