- I. Call the meeting to Order Carolyn Daggett called the meeting to order at 7:08pm.
- II. Additions or Changes to the Agenda- There are no additions or changes to the agenda.
- I. * Motion to approve the September GMM Minutes- Motion made by Megan Kelly, seconded by Janis Graziano. All approve, motion approved.
- II. Guest Speaker- The League was very pleased to welcome Pat Breux, Director of OMH's Suicide Prevention Center as the guest speaker. Pat discussed the history of the Center, as well as her role in helping to educate people regarding suicide prevention. She indicated that suicide is much more common than we think and it is also more preventable than we think. Pat stated that 15-25% of suicides are not reported as a suicide. She also reported that most people who are contemplating suicide want help. Pat discussed 'gatekeeper' trained and stated that medical professionals should be trained in suicide prevention. "Together we can save lives."

 - a. Bylaws Vote- The Code of Conduct changes were reviewed with the League

both at the September GMM and tonight.

*Motion to approve the changes in the Bylaws Code of Conduct as follows:

Amend the Code of Conduct Article II, Section 3 to read as follows:

"All Junior League of Albany members are expected to conduct themselves in a legal, ethical, moral, responsible and respectful manner at all activities and events, as well in internal and external communications related to the Junior League of Albany. This includes League-sponsored events, events sponsored by community partners of the Junior League of Albany and any activity and communications in which members represent the organization."

Add to the Code of Conduct Article II, Section 3 to read as follows:

"League members shall only speak on behalf of the league - in person or in any type of written or electronic format of any type currently in existence or developed in the future - when they are acting in the capacity of their League placement and with authorization of the League President or her designee."

Motion made by Sandy Doellefeld, seconded by Megan Kelly. All approve, motion approved.
